Introduction



Instituted in 1974, The Saudi Metrology and Quality Organization (SASO) is a government body entrusted with all matters and activities related to standardisation, metrology and quality in the Kingdom of Saudi Arabia..

As part of the transformation programme vision 2020-2030 was implemented the Saudi Product Safety Programme (SALEEM) with objective to make sure that all imported products to Saudi Arabia met Saudi Standards and the Technical Regulations developed by SASO, therewith protecting the safety and health of consumers as well as the environment from hazardous, unsafe, counterfeit and potentially dangerous products.

To efficiently implement the SALEEM Programme, SASO initiated SABER System, a website portal for the compulsory registration of every product imported to the Kingdom of Saudi Arabia and the issuance of Product Shipment Certificate.

Sunchine Inspection is approved and authorized by SASO to issue the mandatory product certificate (PCoC) for the exports of regulated products to Saudi Arabia from Asia and Australia.

Our mandate involves undertaking conformity assessment activities for importers and exporters and issuing relevant certificates of conformity on SABER platform for regulated products which comply with KSA SABER & SALEEM requirements

Every shipment of regulated products entering into Saudi Arabia should be accompanied by a Shipment Certificate of Conformity (SCoC) which is compulsory for Import Customs Clearance. In case of the absence of a valid SCoC certificate, Saudi Customs will reject the consignment at destination and the shipment will be returned.

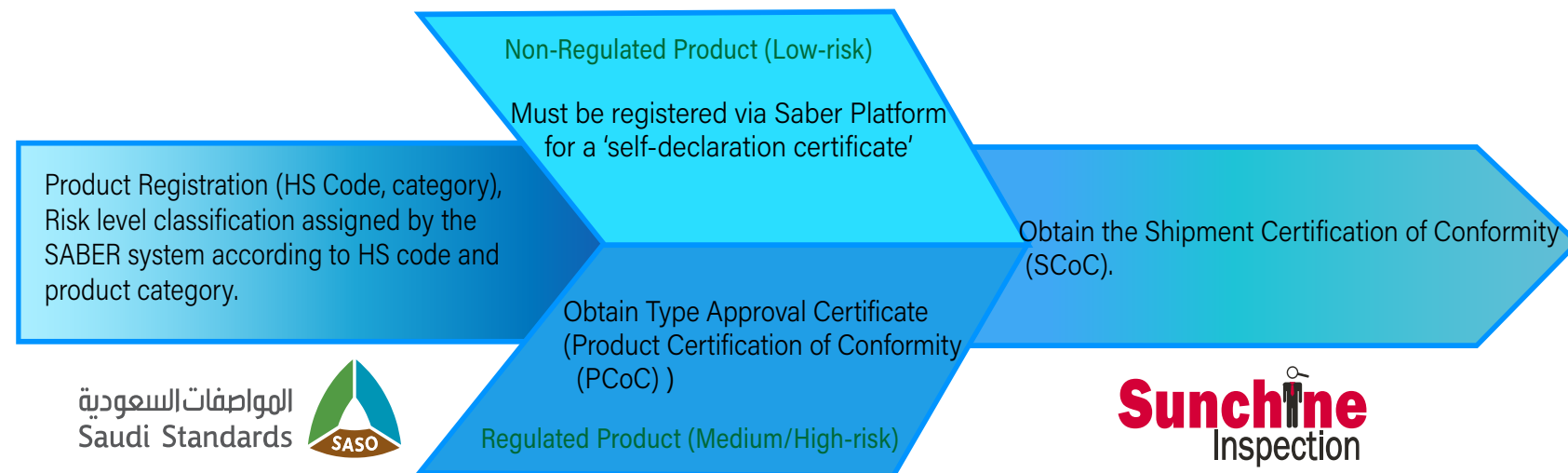


SASO/SALEEM Programme Scope

The Kingdom of Saudi Arabia requires SASO technical regulations to apply to all product shipments entering their country. Consequently, all products bound to Saudi Arabia should be duly registered on the SABER/SALEEM platform and accompanied by a Certificate of Conformity (SCoC) for both non-regulated and regulated products. In addition, for regulated products, any export consignment to Saudi Arabia should have also a Product Conformity Certificate (PCoC) issued by a SASO Notified Certification Body for regulated products.

On January 1, 2019, The Saudi Metrology and Quality Organization (SASO) officially launched the Saber electronic platform for its Saudi Product Safety Programme (SALEEM) which the aims of easing and accelerating procedures for the entrance of products into the KSA market in coordination with the Saudi Customs and at the same ensuring that products are free from defects that may affect the health and safety of the consumer.

On January 15, 2020, the Saber certification replaced the old SASO certification system, and all products can be successfully registered and cleared by implementing the SABER certification.



All exports to the Kingdom of Saudi Arabia (KSA) are subject to mandatory certification under the SABER SALEEM program enforced by the Ministry of Investment(MISA) through the responsibility of the Saudi Standards, Metrology and Quality Organization (SASO).

The Saber certificates are used to clear the consignments from the customs.

SABER TERMINOLOGY

►Non-Regulated Products:

Non-regulated products are not included in technical regulations. However, since January 2021, every imported or local non-regulated product must be registered for self-declaration through the Saber platform, demonstrating their origin and compliance with SASO's applicable regulations and then, will be issued a Shipping Compliance Certificate.

Photos of non-regulated products registered on SABER shall be mandatory uploaded starting on 15th of December 2022.

►Regulated Products:

Regulated Products fall within specific technical regulations defined per categories and based on the level and severity of risk (medium and high).

►Product Certification of Conformity (PCoC):

This Saber Certificate of Conformity is issued to register a product and is valid for one year. Obtaining the PCoC certificate is mandatory only for regulated products. Once the regulated product has achieved Product Conformity Certification (PCoC), it will then be qualified to apply for Shipment Conformity Certification (SCoC).

►Shipment Certification of Conformity (SCoC):

The Shipment Certification of Conformity (SCoC) is mandatory to issue for every consignment of Regulated and Non-Regulated products. It shall be valid for one shipment only.

►SASO Approved Certification Body:

Certification body notified by The Saudi Standards, Metrology and Quality Organisation (SASO). Sunchine Quality Control Technology Service Co., Ltd., is an approved SASO Certification body as notified Saudi SASO / Saber Certification Body.(CB No. P-CB 0542).

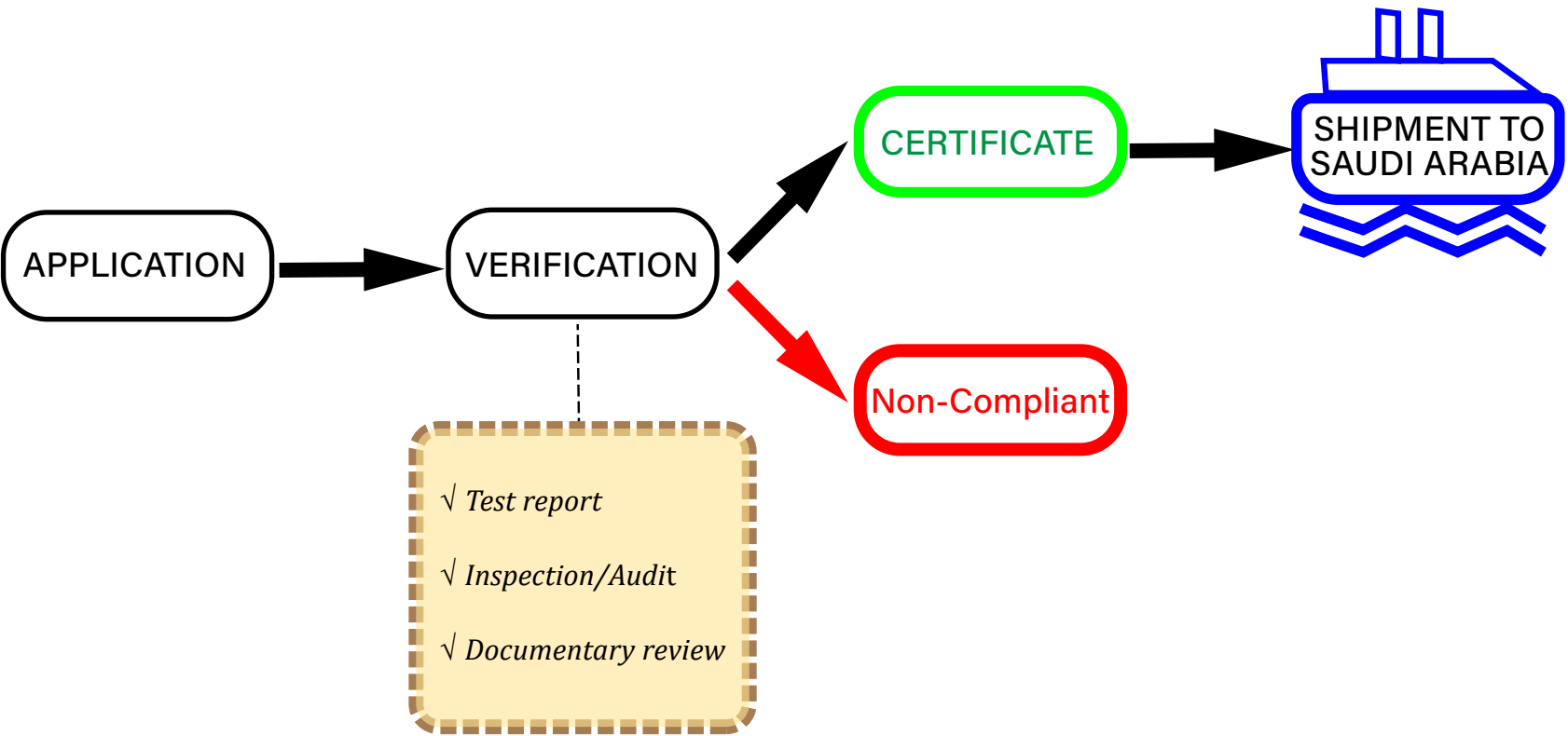

Certification process



A Product Certification of Conformity issued by an “ accredited and notified certification body” recognized, approved and registered by The Saudi Standards, Metrology and Quality Organisation (SASO) like Sunchine Inspection is mandatory for all regulated products imported into Saudi Arabia.

Sunchine Quality Control Technology Service Co. Ltd, brand name Sunchine Inspection, was recognized on June 30th, 2022, by SASO as Conformity Assessment Body to issue the Product Certificate of Conformity (PCoC) for export of regulated products from Asia and Australia Area into the Kingdom of Saudi Arabia.

Effective as from November 05th, 2023, Sunchine Inspection Quality Control Technology Service CO., Ltd.’s accreditation scope as SASO approved Certification Body (P-CB 0542) is expanded from 16 to 34 Technical Regulations Categories (TR) as listed in the two previous pages of this brochure.

Our company Sunchine Inspection has acquired along the years a strong knowledge of product and testing compliance and has in-depth grasp and understanding of the Implementation of SALEEM-SABER Program. All documents provided by every client

Documents required in the Product Registration Process (if proceeded by the Sunchine Inspection on importer request)

1. Power of attorney, signed and sealed by the importer.
2. Registration application form for the product model required for registration.
3. The Company Business License of Exporter and Importer.
4. Account number and password of SABER platform.
5. Trademark photos for each model of product.
6. Photo of the Product (at least six face photos per product) and packaging photos.

Documents required for Product Certification Process

1. RFC (Request for Certification Form).
2. Technical Documentation.
3. Test reports issued by an ISO/IEC 17025 accredited laboratory.
4. Instructions.
5. Provide photos with product packaging, label, identification, power plug (if involved).
6. Business registration certificate of the importer.
7. Energy Efficiency Certificate (if applicable).
8. G-mark Certificate (if applicable).
9. IECEE Certificate (if applicable).

Step 1 - Importer Registration on Saber Platform

- ✓ Registering importer information in Saber platform.
- ✓ Importer has to assign contact officers.

Step 2 - Adding the Products on Saber Platform

All products, notwithstanding of whether they are Non-Regulated or Regulated, should be registered in the Saber platform.

- ✓ Adding Products information as well as photos in the Saber Platform.
- ✓ For every added product must be provided the detailed product information and photos (at least six faces photos per product) and packaging photos.
- ✓ Products are classified to Non-Regulated and Regulated based on the product HS code.

Step 3 - Request and Issuance of the Product Certification of Conformity (PCoC)

The Regulated products only (Medium- and high-risk products governed by SASO Technical Regulations) require a PCoC.

- ✓ For regulated products, the importer proceeds to request with the SASO certification bodies to issue a Product Certificate.
- ✓ Once specified, a list of SASO Certification Bodies notified for the same Technical Regulation is presented, the importer has to appoint a Certification Body (CB) such as Sunchine Quality Control Technology Service (SQCT) for issuing the Product Certificate.
- ✓ The Certification Body (in this instance SQCT) contacts the importer to arrange the activities required for Conformity Assessment.
- ✓ The importer must provide technical documentation (such as product photos, technical documents and test reports issued by an ISO/IEC 17025 accredited laboratory, etc. Required documentation varies depending on product type.
- ✓ Once the Certification Body has completed its assessment procedure and found the product conforming to the requirements, The Product Certification of Conformity (PCoC) is issued. The validity of the PCoC is for 1 year.
- ✓ If the product obtained an equivalent certificate, the PCoC is still required.

Step 4: Shipment Certificate of Conformity (SCoC) Request and Issuance (Mandatory for Regulated and Non-regulated Products)

- ✓ Shipment Certificate of Conformity (SCoC) is mandatory and shall be issued for each shipment of both regulated and non-regulated products.
- ✓ For Non-Regulated products, the Certificate of Conformity (SCoC) is obtained after SASO's approval of the importer "self-declaration" filled by the importer on Saber platform.
- ✓ Regarding regulated products, uniquely those products which have obtained Product Certificate of Conformity (PCoC) are entitled to be added for the Shipment Certificate (SCoC).
- ✓ Importer has to provide details of every of the products included in the consignment such as invoice, packing list, certificate of origin, Barcode as well as bill of lading.
- ✓ Concerning regulated items in the invoice, SABER will send the request to the certification body who issued the Product Certificate of Conformity (PCoC) to perform conformity assurance activities for regulated items included the invoice.
- ✓ The Certification Body (CB) will have to assess the compliance of the product and then upon satisfactory results the CB will issue the Shipment Certificate of Conformity (SCoC).

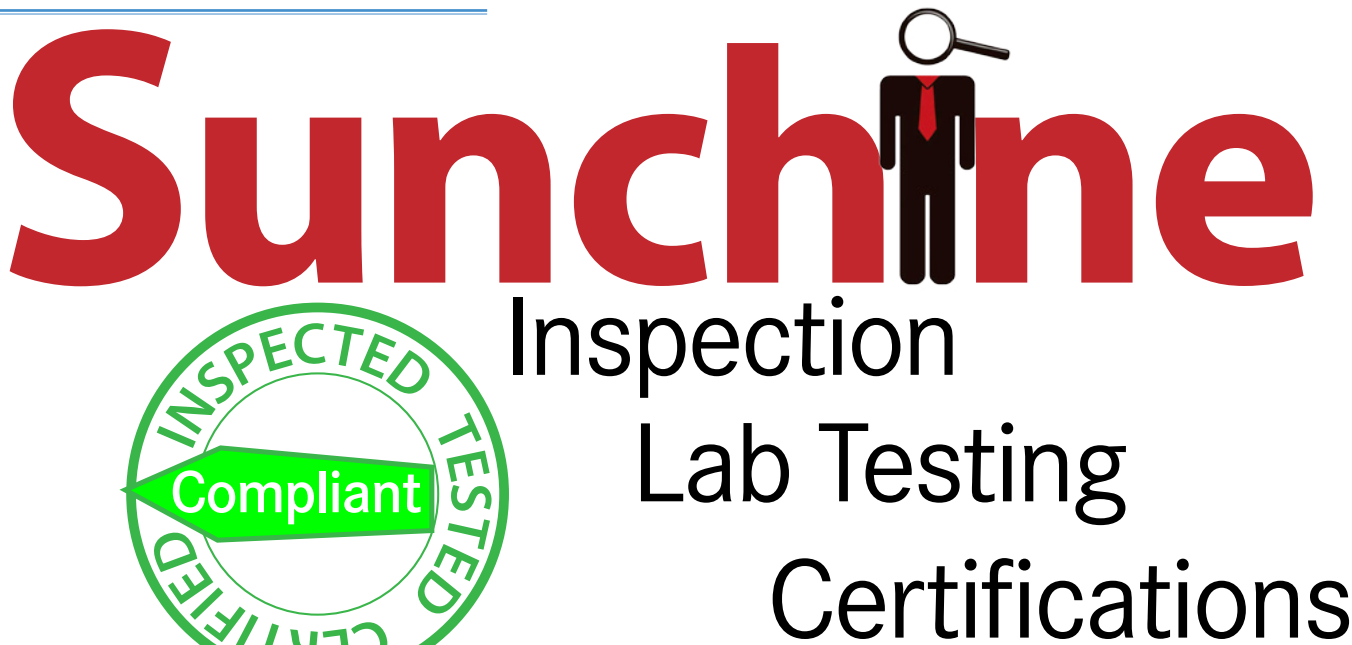
